DOCK HIRE TERMS & CONDITIONS

1. Availability & Booking

- The Dock is available to rent on a weekly basis from Monday to Monday 9am. Other docking times maybe available by prior arrangement.
- A non-refundable deposit of £50 is to be paid to confirm each week of booking and will be deducted from the cost of hire.
- In addition to the cost of hire a £200 CASH deposit is to be paid on the first day of hire, which will be refunded at the end of the hire period and when we are satisfied that there is no loss, damage or breakages.
- A copy of the boat's insurance is required prior to the commencement of hire.

2. Payment & Refunds

- All fees for Dock & Tool Hire to be paid in full prior to commencement of Hire.
- There are no refunds for unused periods of Hire.

3. During Hire

- Only 1 vessel and up to 2 persons in the Dock per Hire period.
- Any additional time required is subject to availability.
- NO Smoking inside the Dock or the Vessel whilst inside the Dock
- NO Fires or Stoves to be used.
- NO Engines Running.
- NO Naked flame appliances to be used ie cooking.
- NO Spraying of paints unless by prior agreement.
- Noisy Work permitted 8am to 5pm Monday to Friday, 8am to 1pm Saturday only. **NO Noisy work on a Sunday or outside of these hours.**
- Cars are only permitted in the designated parking areas.
- All paint soiled rags/rollers/masking materials to be safely disposed of at the end of every day and not stored in the Dock.
- When leaving the Dock during your hire period please ensure;
 - All Batteries are isolated
 - Isolate Gas
 - Paint soiled materials are disposed of in the bin (some material will spontaneously combust)
 - Any Tools Hired are locked away in the cupboard provided
 - The Dock is locked

4. Use of Tools & Tool Hire

- NO Welding or Hot Work, including hot air guns. Hot Work maybe permitted outside of Dock by prior arrangement.
- The Hirer is responsible for assessing the need for and supplying their personal protective equipment. This may include Anti Vibration Gloves should they be hiring tools.
- Tools that are rented will be paid for in full if lost or damaged or stolen.
- Secure Storage is provided which must be used when the tools are not in use.

5. End of Hire

- Assuming there is no loss, damage or breakages the £200 cash deposit will be refunded.

Anyone not adhering to the above Terms will have the remainder of their Hire cancelled, whether work is complete or not and will leave the Dock immediately.

No refunds will be given.
